## **Course Description**

(Credits: 1) An introductory course on makerspace hands-on skills for prototyping and invention. Exploration of makerspace safety, hand tools, common engineering fasteners, design notebooks, power tools, solid modeling, 3D printing, electrical soldering, wearable electronics, and other maker tools for engineering prototyping. Students will complete individual hands-on projects utilizing makerspace skills introduced. No prior knowledge or experience necessary.

# In-Class Recording

A student who publishes a recording without written consent may be subject to a civil cause of action instituted by a person injured by the publication and/or discipline under UF Regulation 4.040 Student Honor Code and Student Conduct Code.
